1. Terms and Conditions - Application

- 1.1 You agree that your use of this Website and the purchase of any movie tickets will be governed by these terms and conditions ("Terms of Use") and the terms and conditions set out in the Tivoli Privacy Policy which appears on this Site. As these Terms of Use and the Privacy Policy are important legal documents, we recommend that you read both documents before taking any further steps on this Site. Your continued use of this Site will be treated by the Tivoli as your acceptance to the Terms and Conditions and Privacy Policy. If you do not accept these Terms and conditions and the Privacy Policy, you must refrain from using or accessing this Site and any information contained on it.
- 1.2 If the Tivoli suffers or incurs any loss or damage in connection with any breach of these Terms and Conditions you agree to indemnify the Tivoli for those losses and damages.

2. Terms and Conditions - Implied Terms

Where legislation implies in these Terms and Conditions any condition or warranty and that legislation avoids or prohibits provisions in a contract excluding or modifying the application or exercise of or liability under such condition or warranty, the condition or warranty will be deemed to be included in these Terms of Use. However, the liability of The Tivoli for any breach of such condition or warranty or any other breach of these Terms of Use will be limited, at the option of The Tivoli, to one or more of the following:

- 2.1 If the breach relates to goods:
 - (i) the replacement of the goods or the supply of equivalent goods;
 - (ii) the repair of such goods;

(iii) the payment of the cost of replacing the goods or of acquiring equivalent goods; or

(iv) the payment of the cost of having the goods repaired; and

- 2.2 If the breach relates to services:
 - (i) The supplying of the services again; or
 - (ii) The payment of the cost of having the services supplied again.

3. Terms and Conditions - Interpretation

In these Terms and Conditions unless the context otherwise requires:

- 3.1 Australian Consumer Law means Schedule 2 of the Competition and Consumer Act 2010 (Cth).
- 3.2 Cinema is The West Wyalong Community Theatre Incorporated trading as Tivoli West Wyalong (Tivoli)
- 3.3 Intellectual Property means any copyright, patent, trade mark, design, or other related statutory or common law right, anywhere in the world, whether registered or capable of registration or not.

- 3.4 Product means any good or service provided or offered for sale or rental by the Tivoli including (without limitation):
 - (i) movie tickets and alternative content tickets
 - (ii) 3D glasses
 - (iii) gift vouchers
 - (iv) food and beverage items
 - (v) accessories and ancillary services.
- 3.5 Terms means these terms and conditions as amended by the Tivoli from time to time, and include the Tivoli's Privacy Policy
- 3.6 'the Tivoli', 'we', 'us', or 'our' means West Wyalong Community Theatre Incorporated trading as The Tivoli West Wyalong (Tivoli) (INC1800989) (ABN 46 548 635 523)
- 3.7 Site means this Website.

4. Registration

- 4.1. You may be asked to provide personal information to the Tivoli before purchasing any movie tickets from this Website, before entering any competition on the Website or before registering as a member of this Website. If you do not provide that Personal Information to the Tivoli, the Tivoli may not be able to sell you movie tickets, enter you into that competition or register you as a member.
- 4.2 All Personal Information the Tivoli collects from this Website will be maintained in accordance with the Tivoli's Privacy Policy.
- 4.3 You acknowledge that if you do not register as a member of this Website, parts of this Website designed for registered members may not be accessible to you. Employees and volunteers of the Tivoli and its related bodies corporate are entitled to become members of the Website, but are not entitled to enter any competitions on the Website.
- 4.4 The Tivoli will use its reasonable endeavours to maintain the security of any personal information that you provide. This Website has security measures in place to protect the loss, misuse and alteration of the information under the Tivoli's control. However, no data transmission over the internet can be completely secure, and the Tivoli cannot give an absolute assurance that the information you provide to us will be secure at all times.
- 4.5 The Tivoli may use techniques designed to identify fraudulent activities on the Website, such as fraudulent credit card use. If any unauthorised use of your credit card occurs as a result of your credit card purchase on the Website, you should notify your credit card provider in accordance with its reporting rules and procedures.
- 4.6 You agree that the Tivoli may cancel your registration as a member and/or refuse you access to this Website at any time in its sole discretion.

7. Website - Purchasing Products

7.1 Formation of contract

Your use of the Site and/or purchase of any product or service through this Site forms a legally binding agreement between you and the Tivoli. This clause sets out the terms that govern the sale of products to you via the Site.

7.2 Age restriction

Children under the age of 16 must obtain the permission and assistance of their parent or guardian to purchase any product or service through this Site.

7.3 Acknowledgements This clause sets out the Tivoli's policies that may affect your ability to obtain or use any goods or services you purchase via this Site.

8. Website - Sale of Movie Tickets

(Applicable when online purchasing is available)

- 8.1 Movie tickets can only be purchased from this Website by credit card.
- 8.2 Movie tickets purchased via this Website will be available for collection at the Tivoli ticket box office.
- 8.3 Movie tickets purchased via this Website are non-refundable and are not available for exchange, unless required by law.
- 8.4 Prices on this Website include GST where applicable.
- 8.5 Seat allocation (when applicable) for movie tickets purchased via this Website is on a "best available" basis and is carried out by a prescribed computer program. By purchasing movie tickets via this Website you agree that:
 - (a) you accept the seat allocated by the Tivoli to each ticket purchased;

- (b) The Tivoli has made no warranties or representations to you that you will be seated in a particular seat, row or section of the cinema.
- 8.6 You agree that the Tivoli may at its discretion, refuse to sell movie tickets to you or withdraw any movie tickets from sale via this Website.
- 8.7 Movie tickets are made available subject to the classification of the relevant film given by the Office of Film and Literature Classification. Where concession tickets are purchased, suitable identification must be presented upon collection of the tickets.
- 8.8 All transactions are in Australian Currency.
- 8.9 Session times may be subject to change or cancellation without notice. In the rare instance this does occur, the Tivoli will attempt to touch base with all bookings in an attempt to notify customers of this change where possible.

9. Website Content

- 9.1 The Tivoli publishes information on the Site, including information about:
 - (a) movies and movie session times;
 - (b) prices for goods and services;
 - (c) Cinema trading hours; and
 - (d) Cinema facilities and access

10. Website Maintenance

10.1. The Site may be unavailable or operate with reduced functionality from time to time due to maintenance. The Tivoli provides no warranty that the Site will be operational at any time, and no warranties in relation to the content of any other website linked to or from the Site.

11. Website Modifications

- 11.1 You agree that The Tivoli may at any time, in its sole discretion, modify:

- 15.2 You irrevocably submit to and accept the exclusive jurisdiction of any of the Courts of the State of New South Wales or the Commonwealth of Australia and any courts of appeal from these courts.

16. Privacy Policy

- 16.1 The Tivoli respects your right to privacy and has policies and procedures in place to ensure that all personal information collected by the Tivoli is handled sensitively, securely and in accordance with regulatory requirements. You agree to the collection and use by the Program Operator of your personal information in accordance with the Tivoli's Privacy Policy.
- 16.2 Consent to collection and use of personal information The Tivoli collects and handles your personal information in accordance with the Tivoli Privacy Policy, available at tivoliwestwyalong.com.au/privacy By using this Website or by purchasing any products or services from this Website, or by submitting any information to this Website, you agree to the

collection and use by the Tivoli of your personal information in accordance with this policy.

17. Cookies

17.1. The Tivoli uses 'cookies' and other technologies to track your use of this Site and to adjust the Content displayed on this Site. You can disable cookies and the tracking technologies we use and still access the Site.

18. Film Classification

18.1. The Australian Classification Board makes classification decisions about films under the Classification (Publications, Films and Computer Games) Act 1995. The Tivoli may require proof of age identification in order to permit a person entry to a film session.

19. Beverages - Alcoholic and Non alcoholic

- 19.1. The Tivoli does not permit the consumption of alcoholic beverages on its premises unless by prior arrangement of the Tivoli management.
- 19.2 All non alcoholic beverages must be purchased from the Tivoli Candy Bar
- 19.3 The Tivoli reserves the right to refuse patrons entry if this term is not adhered to.
- 19.4 Bag checks may be conducted and patrons refused entry based on any items deemed dangerous to the welfare of staff or others.

20. Food

- 20.1 The Tivoli does not permit outside food brought onto the Tivoli premises unless by prior arrangement with the Tivoli management. All food must be purchased from the Tivoli Candy Bar
- 20.2. The Tivoli reserves the right to refuse entry if this term is not adhered to.
- 20.3. Bag checks may be conducted and patrons refused entry based on any items deemed dangerous to the welfare of staff or others.

21. Tickets

21.1. Ticket Prices

When you purchase tickets, you will be shown the total purchase price which includes:

- (a) the price of each individual ticket
- (b) surcharges if applicable
- (c) online booking fees if applicable
- (d) credit card fees if applicable
- (e) GST
- 21.2. By transacting your purchase you agree to pay the total purchase price in accordance with these Terms and Conditions.

21.3 Concession tickets

The Tivoli may require valid identification before permitting entry to a person holding a concession ticket.

21.4 Free List Tickets Restrictions

The Tivoli may impose a "no free list" or "no free tickets" restriction (NFT) to certain films and screenings in its discretion. NFT is a restriction imposed for selected films and screenings upon their release. It means that no special complimentary coupons, discounts or offers are valid for use on that specific film or screening until the restriction has been lifted. Generally, the NFT restriction will only last the first few weeks after a film's release, although there are exceptions.

22. Tickets: Refund and Return Policy

22.1. Refunds or exchanges are not available if you:

- (a) simply change your mind about Products you have purchased;
- (b) have mistakenly purchased the wrong Product (including mistakes relating to session times, dates or cinema venue); or
- (c) are unable to provide proof of purchase

23. Tickets: Re-sale or Promotional Use

23.1 Products or services obtained from the Tivoli box office, Website or candy bar (including movie tickets and vouchers) may not be re-sold, on-supplied or transferred for commercial, consumer or promotional purposes, bundled with other goods or services, or used for promotional purposes without The Tivoli's prior written consent.

24. Disrupting Events

24.1 The Tivoli's obligations to supply to you Products you have purchased via this Site may be suspended due to circumstances outside The Tivoli's reasonable control (Force Majeure events), such as extreme weather, power outages, natural disasters, fire, industrial action, data or communications failures or shortages, or changes to law.

25. Film Distributor Conditions and Restrictions

25.1 The supply to you of any film related Products is subject to any conditions, limitations or restrictions imposed by relevant studio or distributor for that film

26. Disclosure of Customer Details To Payment Processor

26.1 In addition to the collection of personal information as set out in the The
 Tivoli Privacy Policy, you consent to South West Slopes Credit Union (ABN 80
 087 650 673) collecting your personal information to process payments made

by you on this Site through their payment gateway services.

26.2 Your payment and credit card details submitted using this Site are fully encrypted through industry standard secure software server technology. The Tivoli recommends that you check the SSL/TLS certificate at the time of any purchase to confirm this measure has been taken. If you suspect that unauthorised use of your credit card has occurred as a result of a purchase from this Site, you should notify your credit card provider immediately in accordance with its reporting rules and procedures.

27. Disclaimer

 - (a) the performance, non-performance, purported performance, or delay in performance of any obligation the Tivoli has under these Terms, or in respect of any representation made on this Site
 (b) otherwise in relation to these Terms.
- 28.2 You acknowledge and agree that apart from where required by law, this Website and all Website content are provided "as is" without warranties of any kind, express or implied.
- 28.3 You acknowledge that, apart from where stated to the contrary on this Website, the Tivoli has not made any representations or given any warranties:
 - (a) as to the functionality or content of this Website;
 - (b) as to the accuracy or completeness of any Website content;
 - (c) that access to this Website will be uninterrupted or error free or
 - that the Website or the server which stores and transmits the

30. Obligations

30.1 In performing any of its obligations under these Terms and Conditions, or under any contract it has with you, The Tivoli's only duty is to exercise reasonable care and skill.

31. Exclusion and Limitation of Liability

- 31.1 Subject to clause 28.1 (The Tivoli's obligations) and to the extent permitted by law, the Tivoli excludes all liability of any kind for and in respect of:
 - (a) the accuracy, completeness, fitness for purpose, or legality of any information accessed through or displayed on the Site;
 - (b) the transmission or the reception of or the failure to transmit or to receive any material of whatever nature; and
 - (c) any breach of any statutory or common law duty other than any such liability arising pursuant to these Terms.
